9. DEPOSIT INTEREST - Per Commission Rule A.A.C. R14-2-403(B)(3)
10. RE-ESTABLISHMENT (within 12 months) - Months off system times the monthly minimum per Commission Rule A.A.C. R14-2-403(D)
11. DEFERRED PAYMENT - 1.5% of unpaid monthly balance.
12. LATE PAYMENT CHARGES - 1.5% of unpaid monthly balance.
