On July 27, 2018, Arizona Water Company filed an application with the Arizona Corporation Commission for the approval of permanent adjustments to the rates and charges for water service provided by the Company's Northern Group of water systems. Based on the rates authorized in Docket No. W-01445A-18-0164 on August 19, 2019, a monthly bill for the residential customer in the Verde Valley system with a 3/1" x ¾" meter and average usage of 5,405 gallons per month will increase from \$41.40 to \$45.58, an increase of \$4.18 per month or 10.10% percent. The new rates will be effective on and after September 1, 2019, for Arizona Water Company's Verde Valley system.
