**NOTICE OF RATE CHANGE – SAN MANUEL**

W-01445A-16-0443

On December 30, 2016, Arizona Water Company filed an application with the Arizona Corporation Commission for the approval of permanent adjustments to the rates and charges for water service provided by the Company’s Eastern Group of water systems. Based on the rates authorized in Docket No. W-01445A-16-0443 on February 6, 2018, a monthly bill for the residential customer in the **San Manuel** system with a ¾" x ¾" meter and average usage of 5,131 gallons per month will increase from \$45.64 to \$53.00, an increase of \$7.36 per month or 16.13% percent. The new rates will be effective on and after March 1, 2018, for Arizona Water Company’s **San Manuel** system.

Reconnection for Delinquency	\$32.00, each time customer is disconnected.
Re-Establishment	Eight (8) times the customer's monthly minimum charge, or payment of the minimums since disconnection, whichever is less.
After Hours Service Charge	\$35.00, each service call-out after regular working hours, on Saturdays, on Sundays or holidays.
Returned Payment	\$25.00, each returned payment for insufficient funds.
Meter Re-read	\$25.00 – all meter re-reads
Meter Test	No charge for the first test; for the second test for the same customer within any twelve (12) month period, \$25.00, or actual time and material, whichever is greater.
Late Charge	1.5 percent after 15 days.
