

# GOLDEN CORRIDOR WATER COMPANY

## – 2010 ANNUAL WATER QUALITY REPORT FOR GOLDEN CORRIDOR, PWSID #11-107 –

This report contains important information about your drinking water. *Este informe contiene información muy importante sobre su agua beber.*

Arizona Water Company provides groundwater to customers of Golden Corridor Water Company from wells located throughout the central portions of Casa Grande. **The water supplied by the Company complies with all state and federal safe drinking water standards.**

The data in the accompanying tables are from water samples that have been analyzed by independent laboratories, which are certified by the Arizona Department of Health Services.

In developing new drinking water standards, the EPA has proposed including Radon on the regulated contaminant list with an MCL of 300 to 4000 pCi/L. Arizona Water Company collected samples at a number of its wells in the Casa Grande water system in 1999 and found the average level of Radon to be 483 pCi/L, with a range from 360 to 630 pCi/L. While your drinking water complies with EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant you should ask advice from your health care provider.

Note: Data presented are from the most recent testing done in accordance with applicable regulations. Some constituents are monitored less frequently than once a year because either their concentrations do not change frequently or they are not likely to be detected. Therefore, some of the water quality testing data contained herein, although representative, may be more than one year old. In 2004, the Arizona Department of Environmental Quality (ADEQ) completed a Source Water Assessment of eleven ground water wells, which are the sources of water used by Arizona Water Company's Casa Grande water system. The Assessment reviewed the adjacent land uses that may pose a potential risk to the wells. These risks include, but are not limited to: gas stations, landfills, dry cleaners, agriculture fields, waste water treatment plants, and mining activities. Once ADEQ identified the adjacent land uses, they were ranked as to their potential to affect the wells. The result of the Assessment was a low risk to all the sources of water.

Residents can help protect sources of water by practicing good septic system maintenance, taking hazardous household chemicals to hazardous material collection sites, and limiting pesticide and fertilizer use. #### **The EPA requires that Arizona Water Company provide the following information.**

Arizona Water Company is required to monitor your drinking water for specific contaminants on a regular basis to comply with safe drinking water standards.

In 2008, Arizona Water Company collected water samples for Thallium at Point of Entry (POE) 001 and for Selenium at POE 006, 011, and 012 in the Casa Grande water system; however the state certified lab failed to analyze the samples for these constituents. Although Arizona Water Company does not have water testing data in 2008 for Thallium at POE 001, or for Selenium at POE 006, 011, and 012, levels previously and currently (2011) found in samples from these POEs fully comply with safe drinking water standards. All other POEs in Casa Grande were sampled for Thallium and Selenium in 2008 but these constituents were not detected.

Based on all samples taken to date, Arizona Water Company is confident that your water did not exceed the MCL for Thallium or Selenium. Arizona Water Company is now and will continue taking regular water samples for testing to make sure your water complies with all safe drinking water standards.

Please share this information with other people who drink the water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

This is an alert about your drinking water and a cosmetic dental problem that might affect children under nine years of age. At low levels, fluoride can help prevent cavities, but children drinking water containing more than 2 milligrams per liter (mg/l) of fluoride may develop cosmetic discoloration of their permanent teeth (dental fluorosis). The drinking water provided by your community water system has a fluoride concentration of 0 to 2.1 mg/l.

Dental fluorosis in its moderate or severe forms may result in a brown staining and or pitting of the permanent teeth. This problem occurs only in developing teeth, before they erupt from the gums. Children under nine should be provided with alternative sources of drinking water or water that has been treated to remove the fluoride to avoid the possibility of staining and pitting of their permanent teeth. You may also want to contact your dentist about proper use by young children of fluoride-containing products. Older children and adults may safely drink the water.

Drinking water containing more than 4 mg/l of fluoride (the U.S. Environmental Protection Agency's drinking water standard) can increase your risk of developing bone disease. Your drinking water **does not contain more than 4 mg/l of fluoride**, but we're required to notify you when we discover that the fluoride levels in your drinking water exceed 2 mg/l because of this cosmetic problem.

Some home water treatment units are also available to remove fluoride from drinking water. To learn more about available home water treatment units, you may call NSF International at 1-877-8-NSF-HELP.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of various contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Constituents that may be present in source water include: (A) Microbials, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife. (B) Inorganics, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming. (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses. (D) Organics, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also, come from gas stations, urban stormwater runoff, and septic systems. (E) Radionuclides, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain constituents in water provided by public water systems. FDA regulations establish limits for constituents in bottled water which must provide the same protection for public health.

AL	= Action Level, the concentration of a constituent, which, if exceeded, triggers treatment, or other requirements, which a water system must follow
CDC	= The United States Centers For Disease Control

MCL	= Maximum Contaminant Level, the highest level of a constituent that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
MCLG	= Maximum Contaminant Level Goal, the level of a constituent in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
MRDL	= Maximum Residual Disinfection Level, the highest level of a constituent that is allowed in drinking water
MRDLG	= Maximum Residual Disinfection Level Goal, the level of a drinking water disinfectant in drinking water below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of the disinfectants to control microbial contaminants.
