NOTICE OF RATE CHANGE - Northern Region (Sedona)

Docket No. W-01445A-24-0117

On June 21, 2024, Arizona Water Company filed an application with the Arizona Corporation Commission for the approval of permanent adjustments to the rates and charges for water service provided by the Company's Northern Group of water systems. Based on the rates authorized in Decision Nos. 81422 and 81446, a monthly bill (excluding applicable surcharges and credits) for the residential customer in the **Northern Region (Sedona)** systems with a ¾" x ¾" meter and average usage of 4,265 gallons per month will increase from \$39.92 to \$58.43, an increase of \$18.51 per month or 46.4 percent. The new rates were effective on August 1, 2025, for Arizona Water Company's **Northern Region (Sedona)** systems. The System Improvement Benefits ("SIB") and Arsenic Cost Recovery Mechanism ("ACRM") surcharges were reset to zero, effective August 1, 2025.

Service Charges

Establishment	\$32.00
Guarantee Deposit	Residential – maximum: Two (2) times average customer class bill. Non-Residential – maximum: Two and one-half (2½) times that customer's estimated maximum monthly bill.
Reconnection for Delinquency	\$32.00, each time customer is disconnected.
Re-Establishment	Eight (8) times the customer's monthly minimum charge, or payment of the minimums since disconnection, whichever is less.
After Hours Service Charge	\$35.00, each service call-out after regular working hours, on Saturdays, on Sundays or holidays when such service is at the request of the customer.
Returned Payments	\$25.00, each returned payment for insufficient funds.
Meter Re-read	\$25.00 – all meter re-reads
Meter Test	No charge for the first test; for the second test for the same customer within any twelve (12) month period, \$25.00, or actual time and material, whichever is greater, except that no meter testing fee shall be imposed if the meter is found to be in error by more than 3 percent. as provided in A.A.C. R14-2-408(F).
Late Charge	1.5 percent after 15 days.
